




"My favorite Christmas tradition is decorating the tree. Every year it brings me back to my childhood and great memories."

Livia's WHITE CHOCOLATE CHEX MIX

Every December, my family has an all day affair making Christmas treats in the kitchen. One of my favorite candies that we grew up making was this White Chocolate Chex Mix

INGREDIENTS

- 6 cups Chex cereal
- 6 cups pretzel sticks
- 1 16-oz jar peanuts
- 1 11-oz bag M&M's
- 2 12-oz bags white chocolate chips
- 2 tablespoons vegetable oil
- Wax/parchment paper

DIRECTIONS

- Combine cereal, pretzels, peanuts, and M&M's in a large bowl.
- Line two baking sheets with wax or parchment paper; set aside.
- Combine white chocolate chips and vegetable oil in a microwave-safe bowl.
- Heat and stir at 30-second intervals until chocolate is melted.
- Pour melted chocolate over dry ingredients and gently fold until well combined.
- Spoon mixture onto baking sheets, spread to cover pans.
- Cool in a refrigerator until set. Once hardened, break into chunks and enjoy!
